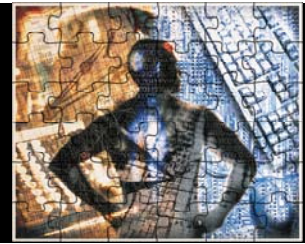

BROWSER-BASED

ClaimsVision™ is engineered in true Thin Client (zero footprint) Architecture, which requires no additional software to run the entire application on any user’s desktop. All that is needed is Internet Explorer 6 or higher. ClaimsVision™ provides highly efficient claims processing using an easy and user-friendly browser navigation model similar to Microsoft Outlook® with folders on the left and applicable pages on the right.

WORKFLOW DRIVEN APPLICATION

ClaimsVision™ was designed to be a claims adjuster/examiner centric application, and provides unlimited depth and flexibility of client set-up and organizational hierarchy to mirror an organization’s current accounting and/or business set-up. The application also includes a powerful Rules Engine with Auto Diaries that automate the claim workflow.

The User drives the ClaimsVision™ process; here are a few examples:

- Entry screens are user configurable, streamlining the entry process and allowing you to add mandatory or optional fields
- Business rules drive your company’s best practices
- Automatic alerts prompt actions to be taken during the claim lifecycle
- Automated routing of vital information
- Automated claims assignment
- Supervisor notification of claims open for more than a user defined number of days
- Notification when a payment limit is exceeded or insufficient reserves are set

Document Management

- Automatic forms creation based upon user definable business rules
- Claims adjuster notified of the form creation automatically through the diary system
- The form is then automatically attached to the claim file
- Easy access to all correspondence by users that have the proper authorization

Policy Information Tracking

- Automated coverage verification
- A policy number assigned to claim after verification
- Business rules automatically notify the adjuster via diary
- Data is extracted from claims system and sent to a policy admin system

ClaimsVision™ is designed to simplify and enhance all B2B communication. Its core integration functionality is built around XML technology and standards allowing unlimited B2B communication with individual state jurisdictions, ISO and 3rd party systems. While ClaimsVision's core functionality is built around XML, it still fully supports text files; HTTPS Post and FTP eliminating labor intensive antiquated EDI.

SCALABLE

By leveraging the latest Microsoft technology, ClaimsVision™ is extremely scalable allowing the processing of millions of claims by thousands of users. The Application Service Provider (ASP) delivery model allows clients to process claims securely from a single location or remotely from multiple locations.

REPORTING

ClaimsVision™ utilizes Microsoft SQL Server Reporting Services (SSRS) including Web-based report access and management, featuring ease of scheduling, categorized reports and Ad hoc reporting tool. The system controls user access, while providing a Business Intelligence platform to align your organization's activities with its goals, turning insight into action thus making more effective decisions more efficiently.

The application provides extremely robust reporting capability including context sensitive reports, application reports and business intelligence risk management analytics including key performance indicators (KPI), pivot tables, graphs, and dashboards with threshold indicators and true as-of point in time comparative analysis.
